- 6) The person should be physically and mentally apt to be a candidate of the executive committee.

- 8) New members shall be accepted on their word that they comply_with membership rules herein.
- 9) Membership can be cancelled without reimbursement of fees by the Managing Committee for non-compliance with rules herein or for failure to abide by mission as stated in Registration.
- 10) Membership shall start on payment of membership fees together with the subscription.
